As part of the new clinical guideline process, an embargoed copy of all final guidelines will now be available to stakeholder organisations two weeks before the official publication. This embargoed version will, however, only be available to stakeholder organisations that comment during the draft consultation period and will also be subject to the signing of a confidentiality form. The confidentiality form will be e-mailed to all stakeholders along with instructions on completing and returning the form within 5 days of the consultation closing.

### **Economic Modelling**

The National Clinical Guideline Centre has produced an economic model in support of their report. The Institute would like to offer stakeholders the opportunity to receive an executable version of this model by email.

Executable copies of the model will be released to you on the basis that you agree in writing to the following conditions for its use. - The economic model and its contents are confidential and are protected by intellectual property rights, which are owned by the National Clinical Guideline Centre. It cannot be used for any purpose other than to inform your understanding of the guideline. Accordingly, neither the model nor its contents should be divulged to anyone other than those individuals within your organisation who need to see to them to enable you to prepare your response. Those to whom you do show the documents must be advised they are bound by the terms of the Confidentiality Acknowledgement and Undertaking Form which will need to be signed and returned to the Institute by your organization prior to receiving a copy of the model. The confidentiality form is available with the rest of the consultation documents on the link above.
- You may not make copies of the file and you must delete the file from your records when the guideline development process is complete. You must confirm to us in writing that you have done so. You may not publish it in whole or part, or use it to inform the development of other economic models.
- The models must not be re-run for purposes other than the testing of its/their reliability.
