2.	Ralph Hammond highlighted the ongoing process in involving the professional network and alliances in responding to NICE calls. He emphasised the importance of getting physiotherapists involved at the early phases of guideline and NICE document development and made it clear that he was available to support this process and advise members	All professional networks and Alliances should review their arrangements for monitoring NICE output, and where appropriate, identify members to represent their PN or Alliance.
